3. CONTRACTOR TO PROVIDE 'WEATHER PATCH' (ACRYLIC COPOLYMER ELASTOMERIC PATCHING COMPOUND) BY DRYVIT OR EQUAL.	
4. CONTRACTOR TO PROVIDE 'WEATHERCOAT' (HIGH PERFORMANCE ACRYLIC WEATHERPROOFING COATING) BY DRYVIT OR EQUAL.
