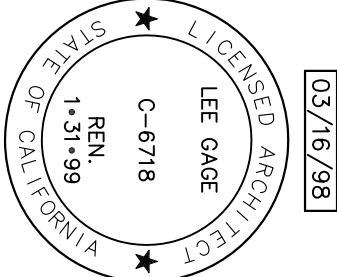


1 ACCESS. W./SHOWER (HDS)
