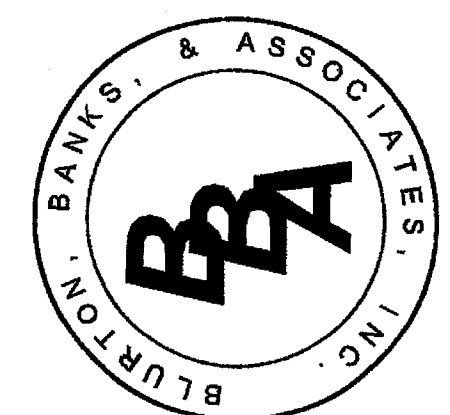
# LEGAL DESCRIPTION

Commence at the Southwest corner of Section 22, Township 16 North, Range 4 East, Warren County, Mississippi; thence North 80°00'00" East, 1323.00 ft.; along said section line, thence North 03°37'00" East, 758.00 ft.; thence North 63°29'00" East, 281.70 ft.; thence South 28°48'00" East, 48.85 ft.; thence North 61°12'00" East, 50.00 ft.; thence North 28°48'00" East, 3.00 ft. to the Point of Beginning of the herein described parcel; thence along the East line of the Interlaid May parcel, as recorded in Deed Book 1129 at page 829 and 830, Warren County, Mississippi, the following course: North 28°45'59" West, 37.16 ft.; thence North 08°04'00" West, 272.71 ft. to a point in the South Right-of-Way of the South Frontage Road; thence along said right-of-way the following course: North 33°09'24" East, 150.68 ft.; thence along a curve to the right, having a radius of 75.43 ft. and a chord length of 105.72 ft., South 51°05'57" East to a Right-of-Way marker; thence South 08°44'52" East, 2.50 ft.; thence along a curve to the left, having a radius of 123.00 ft. and a chord length of 145.11 ft. and a bearing of South 39°05'19" East; thence South 29°03'04" West, 57.84 ft.; thence South 80°52'44" West, 57.84 ft.; thence South 80°52'44" West, 159.41 ft.; thence North 28°48'00" West, 33.71 ft.; thence along the North line of said Campbell property, South 61°21'00" West, 103.00 ft. to the Point of Beginning, containing 1.54 acres, more or less.
